# **Scholarships Available**

North West REC and Basin Electric Power Cooperative will be sponsoring several scholarships to dependents of members of North West REC in 2025. Last year we awarded \$27,000 in scholarships to 62 students!

There will be two \$1,000 scholarship winners from each of the four districts of North West REC (Ida, O'Brien, Plymouth, and Sioux). The selection process for the \$1,000 scholarship winners will be based on a combination of SAT/ACT scores, overall grade-point average, work experience, participation in school and community activities, a personal statement of career goals, and a written reference or appraisal by a third party.

Scholarship applicants, who are not awarded a \$1,000 scholarship award, will be asked to watch an educational video on North West REC and the cooperative model and then complete a questionnaire. This will then enter applicants into a random drawing for a \$500 or \$250 scholarship. All applicants will receive at least a \$250 scholarship. Details of this video and questionnaire will be communicated at a later date.

North West REC members may qualify if their dependent meets the following criteria:

- Must be a U.S. citizen.
- Are current North West REC members.
- Must be a senior in high school in our service territory for the 2024-2025 school year and planning to enroll in a full-time undergraduate or graduate course of study at an accredited two-year or four-year college, university, or vocational/ technical school.
- Submit an application as provided by North West REC.
- Return all completed forms no later than Friday, February 14, 2025.

If you have any questions, please call us at 712-707-4935 or 800-766-2099. All entries for the scholarship must be returned to the REC no later than Friday, February 14, 2025!

### **Director Qualifications:**

The Cooperative's by-laws establish that a director must be a member, individually, and a bona-fide resident of the district from which they are elected to represent.

#### To do a competent job, a director is expected to:

- Attend all regular monthly board meetings. The Board holds daytime meetings usually scheduled for the last Thursday of each month. Meetings last approximately six hours.
- Attend the annual meeting of the Cooperative.
- Attend meetings of related organizations such as Northwest Iowa Power Cooperative, Iowa Association of Electric Cooperatives, National Rural Electric Cooperative Association, National Rural Utilities Cooperative Finance Corporation, Federated Insurance, and others, when necessary.
- Read and be familiar with information, data and reports received from cooperative management, national, state and other local associations.
- Establish and maintain contact with members of the Cooperative in his or her locale.
- Work in harmony with the other members of the Board and employees for the good of all members of the Cooperative.
- Attend special meetings of the Board, or of committees to which assigned by the president.

# **Operation Round Up Disbursements Surpass \$750,000 Since the Program Was Started**



In 1999 we started our Operation Round-Up Trust program for the purpose of providing assistance to charitable organizations and families in need. With the donations that were approved at the November board meeting, we have now surpassed \$750,000 in total disbursements over the last 25 years.

This program is made possible by the generosity and compassion of our participating members, who agree to round up their monthly electric bills to the next dollar. The rounded-up cents are placed in the Operation Round Up Trust account that is overseen by the North West REC Board of Directors.

During this time of year, it's good to reflect on the many blessings that we all enjoy and also on the challenges and hardships that many individuals and families have faced in recent months. We want to thank all of our members who have generously supported this important program over the years', and we encourage other members to consider signing up to participate. For an average of only 50 cents per month - \$6.00 per year, you can see the significant impact it can have and the good it can do for many organizations and families throughout northwest Iowa.

One of our strategic goals is to continue to enhance our member engagement opportunities with our members. # Switch Makes Cents Update

We continue to make good progress with our Switch Makes Cents and metering system upgrade and wanted to share an update with our members. In 2020, the Board of Directors approved a plan to replace our load management system and our metering system with a new radio frequency (RF) system that would be able to have both systems operating on the same network.

Following COVID, there were some long delays in getting delivery of the load management switches and meters. Our Member Service Department employees got started with the changeouts in 2022 and as of the end of this year, we will have most of the meters changed out to the new RF meters and approximately 50% of the load management switches. We appreciate the hard work of our employees who have been involved with this big project. We have approximately 15,000 meters and 7,000 load management switches on our system, so this is a very big undertaking to get them all changed out.

Our load management system enables us to interrupt load during peak times and results in over \$1.5 million in annual power cost savings for NWREC and our members. Having accurate meters that are programmable, and which can provide not only real time




kilowatthour usage information but also KW demand readings is important for our billing, member service, and operations departments.

We want to thank our members for their cooperation and understanding as we complete this important project. A majority of the load management switches are installed in members basements so it takes communication and coordination to get things scheduled.

# 2025 Energy Efficiency Rebates

All changes to our energy efficiency rebates are effective as of January 1<sup>st</sup>, 2025. We want to make sure all our members are aware of the current rebates. See the full list of rebates we offer below.

Rebate forms for Building Insulation and Electric Vehicle Chargers are available at our offices and can also be found on our website at www.nwrec.coop under the member services tab.

No form is needed for the other rebates, simply submit a copy of the invoice for the rebated equipment to North West REC, and a representative from North West REC will call you to set up a time to inspect the installation prior to the rebate being paid to verify that it has been installed and is operating.

Switch Makes Cents is a load management program that our cooperative has offered to members since SWITCH Makes Cents is a load management program that the technology. It is energy efficient and curbs electric SMART? 1985. In fact, our co-op served as an early pioneer of this technology. It is energy efficient and curbs electric demand during peak times to prevent the need to build additional generating facilities or incur higher wholesale power costs. The Switch Makes Cents load management program reduces our system peak by as much as 20 megawatts (MW) in the summer and 12 MW in the winter...the equivalent of powering approximately 3,200 homes! This is done by reducing total demand during times of peak-use, generally between 6-10AM and 3-9PM, when people are commonly at home running washers, dryers, dishwashers, air conditioners, heaters and so on.

## North West REC will send two high school juniors on an all-expenses paid Youth Tour trip to Washington, D.C. on June 15-21, 2025!



Two students will be selected from eligible candidates to attend the 2025 Youth Tour in Washington, D.C., from June 15-21, with orientation June 15th in Des Moines, along with 40 other student leaders from Iowa. The Iowa Youth Tour group will join with hundreds of students from across the country as they learn more about electric cooperatives and American history and come home with a greater understanding of their role as an American citizen. Students will also learn about U.S. government and meet with their members of Congress. On the trip, students take in the sights of D.C. as they visit monuments, museums, and historical landmarks.
