

# An Easier Way TO PAY

Save time and money with the automatic bank draft and e-bill payment plan by having your monthly electric bill deducted from your bank account and receiving your bill electronically. You would no longer receive printed billing statements in the mail.

### Why sign up for the automatic bank draft and e-bill payment plan?

- No more writing a check to North West REC for your electric bill
- Your electric bill will be paid on the due date no worrying about getting your check to our office on time
- Accurate record keeping from your financial institution showing the direct payment you make to North West REC on your bank statement
- Access to your electric information at all times online view your billing and payment history with bill details (you will need to go to our website http://www.nwrec.coop to register your e-mail address and password for the e-bill)

#### What if I am already participating in the automatic bank draft payment plan?

- You will need to sign up for e-bill online
- Check the box on the coupon to sign up for e-bill, along with your signature and date

Your financial institution automatically transfers the amount of your monthly electric bill from your account to North West REC each month. The amount transferred will also appear on your monthly bank statement. The amount due will be transferred out of your account on the <u>8th of each month</u> for payment of your electric bill. You will receive an e-mail notice on the 20th of each month that your monthly electric bill is now ready to be viewed. This will indicate the amount to be withdrawn from your account. 
# MANAGER'S Report



#### "ALL OF THE ABOVE" GENERATION

One of the questions I am often asked by our members is "What is North West REC's power supply mix?" To answer this, I need to give a little background on how we purchase the electric power that we sell to our members.

North West REC (NWREC) has an "all requirements" contract with Northwest Iowa Power Cooperative (NIPCO). NIPCO receives approximately 23% of its power supply from hydro facilities on the Missouri River. The remaining 77% comes from Basin Electric Power Cooperative. Basin has a diverse mix of generation including coal, natural gas, wind and nuclear. When you blend all of the various generation resources, the mix of electric power that NIPCO provides NWREC and our members is 23% hydro, 36% coal, 16% wind, 17% natural gas, 7% oil and other, and 1% nuclear.







## PERDUE PREMIUM MEATS SIGNS UP FOR PRAIRIE WINDS PROGRAM

We were pleased to recently work with Gary Malenke at Perdue Premium Meats (formerly Sioux Preme Packing Company) to sign them up for the Prairie Winds program. This is a green energy program that Basin Electric and NIPCO developed in 2002. This program allows members of NWREC to voluntarily contribute to the development of alternate energy production facilities, which may include wind, biomass or solar.

The corporate strategy of Perdue Premium Meats is to transition to fully support renewable energy and this program was a good fit for them. Malenke states, "We have a growing customer base that has interest in renewable energy, which also aligns with the company's environmental responsibility goals. We are proud to partner with our local cooperative, NWREC, who has provided us access to this program." Through this program, Perdue Premium Meats has signed up for enough renewable energy purchases per year to equal 100% of their annual electricity requirement to operate their facility south of Sioux Center. They are the first commercial and industrial customer of NWREC to sign up for 100% of their annual kWh consumption through this program.

We want to remind our members that this Prairie Winds program is available to any member who would be interested in supporting the further development of renewable energy. The price for a contribution is only 2/10 of a cent per kWh. Please contact us if you have any questions. You can also go on our web site at www.nwrec. coop to sign up.

#### **NWREC LINEMAN HELPS LEAD NRECA INTERNATIONAL PROJECT IN GUATEMALA**

We are excited that one of our linemen, Mike Berkenpas, is helping to lead a project in Guatemala that will bring electricity to 42 homes, a health post and school. It's hard to imagine that there are still places in the world that don't have electricity something that we all enjoy and somewhat take for granted.



Iowa's electric cooperatives, through the leadership of our Iowa Association of Electric Cooperatives, are partnering with co-ops from Illinois and Wisconsin and staff from the NRECA International program. Mike is



serving as a leader from lowa, and he made a trip to Guatemala the first week of June along with the other leaders, to make plans for the project. A larger group will return for two weeks this fall to complete the project and to help bring electricity to the village of Salinas 7 Cerros. This is in the north central part of Guatemala.

We thank Mike for his willingness to volunteer to help with this project. An update and other pictures will be shared this fall after they return.

# ou PULL THE PLUG

If you currently own an older, inefficient refrigerator, freezer or window air conditioning unit, North West REC will pay you \$50 to "Pull the Plug" on the unit and recycle it at any certified recycling or de-manufacturing facility, such as a county landfill.

Effective March 31, 2019, North West REC will no longer contract with a third-party vendor to remove inefficient appliances from your home. As an added incentive, we have increased our rebate amount from \$25 to \$50. Up to three (3) appliances may be recycled per calendar year.

Appliances must be clean, empty and in working order when recycled/dropped off at a certified location. A dated copy of a receipt by the certified vendor/landfill/recycler must accompany the rebate application form which is available from our office or can be found on our website.

We're excited to share our cooperative story at the lowa State Fair; stop by our booth and say hello!!




# ENERGY TRAIL TOUR Winners Announced
