Reminder About Mailing...

Watch your mail for your Annual District Meeting mailing which will include your registration card. Please bring this card with you when coming to the meeting. It will be used for the drawing of door prizes.

You will also receive your "ballot for director" in this mailing if you are a member in Districts 1, 2 and 3. Be sure to vote and mail your ballot to the cooperative in the envelope included in the mailing. Note to District 4 members: There will not be an election for directors in District 4.

RECYCLING PROGRAM TO CHANGE

If you currently own an older, inefficient refrigerator, freezer or window air conditioning unit, North West REC will pay you \$50 to "Pull the Plug" on the unit and recycle it at any certified recycling or de-manufacturing facility, such as a county landfill.

Effective March 31, 2019, North West REC will no longer contract with a third-party vendor to remove inefficient appliances from your home. As an added incentive, we have increased our rebate amount from \$25 to \$50. Up to three (3) appliances may be recycled per calendar year.

Appliances must be clean, empty and in working order when recycled/dropped off at a certified location. A dated copy of a receipt by the certified vendor/landfill/recycler must accompany the rebate application form which is available from our office or can be found on our website.

MANAGER'S Report

"We set high goals for the reliability and accessibility of the power we provide to you."

Board Approves a Reduced Power Cost Adjustment for 2019

At the January Board Meeting, the board approved management's recommendation to apply a 1.2 mill (\$0.0012/kWh) power cost adjustment to member bills in 2019. This is good news for our members as it is actually lower than the PCA in 2018, which was 1.6 mills. All base rates will remain the same. As a reminder, the PCA is a method of either collecting from or returning to the members the difference in wholesale power costs compared to the base wholesale rate that was used to establish the current electric rate.

Two months ago, I shared the positive news that the Board had decided to keep our rates stable for the next two years and that the PCA would also be kept the same at 1.6 mills. In December, we received a \$245,000 bill credit from our power supplier, NIPCO, and we are passing that through to our members by reducing the PCA.

Your Cooperative had a very good year in 2018, and we are looking forward to continuing to provide excellent service to our members in 2019 at the lowest possible costs.



Reliability is Our Daily Priority

We know that our member-owners' satisfaction with North West REC (NWREC) is directly related to the reliability and affordability of the services we provide. The cornerstone of our business model is providing service that meets or exceeds your expectations, which is why reliability is one of our top priorities. In fact, reliability is one of the four key pillars of our overall mission to provide power that is safe, reliable, affordable and environmentally responsible.



I'm pleased to report that we had another good year of providing reliable service for our members in 2018. We have several indices that we use to measure how we are performing with regards to reliability. Two of them that we use most often are the system average interruption index (SAIDI) and overall reliability rate. We also refer to SAIDI as average outage minutes, and for 2018 we had a very low 67 minutes of average outage time per member. Our overall reliability rate for the year was 99.99%.

As I am preparing this article, we have just experienced some severe cold weather. Last week it was 25 degrees below zero and last night it was 10 below zero with 30 below wind chill factor. Yesterday afternoon we had an outage in the Hawarden area that impacted over 400 of our members, and at times like this, we all quickly realize how important reliable electric service is. Our power supplier, NIPCO, had a transformer failure at the substation. Our crews were able to do some switching and looped in other substations so we could get our members back in service in approximately two hours.

Due to the extreme cold temperatures and amount of electric demand on the system, the decision was made to bring in a portable substation that NIPCO keeps at their Le Mars facility. We were concerned that in the event of another substation outage, the outage time could be lengthy and a large number of members would suffer from the cold. Through some outstanding coordination between our staff, the NIPCO control center and the NIPCO and NWREC line crews, the portable substation was installed and energized by 9:00 p.m. that evening. We thank NIPCO and all of their employees as well as all of our employees who were involved for doing a great job under very challenging working conditions. I'm very proud of their work ethic and the professionalism they demonstrated in carrying out this challenging outage restoration project.



I'm also thankful for their dedication and the great work they do on behalf of our members every day.



This type of situation reminds us of the importance of having redundancy, both on our distribution system and also NIPCO's transmission and substation network. Reliability isn't something that happens by chance. Throughout the year, our distribution and transmission infrastructure – which includes such things as poles, wires, transformers and substations – is subject to many perils. On any given day, ice storms, high winds, tornadoes, squirrels and birds, and even errant drivers, can interrupt electric service and cause a power outage. We are constantly preparing for the things we can control on our system, such as planned and routine maintenance outages, and for unexpected outages that are often beyond our control. We set high goals for the reliability and accessibility of the power we provide to you.

Providing the reliable service our members expect and deserve takes a significant investment in new system improvements every year and this was another reminder of how necessary and important these investments are. I'm pleased that your board of directors understands this and is supportive of the Capital Outlay Budgets we prepare and ask them to approve each year.

Board Room Summary - December/January

The following is a brief summary of the discussions and decisions from the December and January board meetings:

- Received monthly safety, operations and financial reports from staff.
- Approved the 2019 Operating Budget. The budget projects \$57 million in total revenues and \$5.1 million in total margins.
- Heard a report about the Member Patronage Days in December which were very well attended by our members.
- Received an update on the services offered and number of subscribers we have with our N.E.T. Broadband partnership.
- Approved a new banking representative on our revolving loan fund review committee.
- Manager Korver reported on several economic development projects that are nearing completion or are underway.
- Heard reports from Director Tom Wagner on the recent NIPCO and Basin Board Meetings.
- Received an update on the larger than anticipated patronage assignment from NIPCO that was included in the December financials and significantly increased total margins for the year. The board will decide on the assignment of these margins to our members at the next board meeting.
- Heard reports from the delegates who attended the IAEC and Mid West Electric Annual Meetings.
- Reviewed Sections 6 and 7 of the NRECA Governance Report.
- Approved membership applications for new members.
- Discussed the recent Strategic Planning meeting that was held the first week of January. Management will be presenting implementation plan updates to the board throughout the first half of 2019.
- Approved a 1.2 mill power cost adjustment (PCA) for 2019. This is lower than the 2018 PCA which was 1.6 mills.
- Heard a report on the Nominating Committee Meeting and approved final plans for the upcoming District and Annual Meetings.

Powerline Scholarships

North West REC is again sponsoring a powerline scholarship. This program is designed to assist persons enrolled in a course of powerline training at Northwest Iowa Community College in Sheldon.

A \$500 scholarship will be awarded to an individual who has met the eligibility requirements. To be considered for the scholarship, applicants must meet the following criteria:

- Reside in the four county area served by North West REC (Ida, Plymouth, O'Brien and Sioux Counties)
- Be a member or the child of a member of North West REC
- Be accepted as a full time student in the powerline program at Northwest Iowa Community College in Sheldon
- File a scholarship application with North West REC by Friday, March 29, 2019


All applicants are required to submit an application form as well as their most recent academic transcript. The criteria for the award will be based upon community and school activities, potential for success and grade point average.
