REC DAY ON THE HILL

In March, over 200 rural electric cooperative (REC) employees and directors from all over Iowa traveled to the Iowa State Capitol for the annual "REC Day on the Hill" event to advocate for important issues related to safe, reliable, and affordable electricity for their members. North West REC employees Rob Driesen and James Vondrak and District 1 director Steve Abma were among those who attended.

After being briefed on state and federal legislative issues, co-op representatives met with their local elected officials on the first floor rotunda of the Capitol. North West REC representatives were able to meet with most of the local state legislators who were very supportive of policies that are in the best interest of North West REC and its members.

Some of the issues co-ops educated legislators on include:

- Line personnel safety
- Rural economic development
- Utility-owned solar

The Iowa Association of Electric Cooperatives received a standing ovation from the Iowa House for its 75 years of service. Co-op representatives personally witnessed Governor Branstad sign into law a bill related to energy efficiency reporting that was passed unanimously by the legislature. They were able to thank him and the legislators for passing a bill that will make North West REC and other co-ops in the state operate more efficiently by streamlining required energy efficiency reporting.



OPERATION ROUND UP REPORT

Disbursements made from North West REC's Operation Round Up Trust in the first quarter of 2017 totaled \$5,600. This brings the total disbursements made from Operation Round Up since its inception in June of 1999 to \$383,955. Many people have been helped thanks to our members.

PRAIRIE WINDS PROGRAM UPDATE

Members of North West REC can support renewable energy through the Prairie Winds program. This program allows individual members to voluntarily contribute to the development of alternate energy production facilities.

Persons who choose to participate in Prairie Winds will pay 20 cents per 100 kilowatt-hour block per month. This is reduced from 50 cents in 2010.

Through this program, members will not be directly purchasing alternate energy, but the extra fee does go to support several wind turbines in the Dakotas, which feed wind-generated electricity into the transmission system that powers North West REC.

Continued Focus on Member Engagement

In our last newsletter, we shared the results of our recent member survey and our customer satisfaction index score and also shared our appreciation for the loyalty and support we receive from our members. We don't take this for granted, and we also know that continued improvement in our member engagement opportunities is one of the keys to maintaining and improving member loyalty and support.

Through our recent discussions about ideas for increasing member engagement, we decided to start a new contest in our newsletter. STATEMENT OF NONDISCRIMINATION

REVOLVING LOAN FUND

North West REC created the Community/Economic Development Revolving Loan Fund (RLF) to improve the quality of life in rural areas by contributing to long term improvement in the local economy.

The RFL is a local funding source with a goal of providing low interest loans to assist local economic and community development projects. Our priorities include job creation and retention, diversification of the local economy, improving the skills of the rural workforce, and upgrading the public infrastructure to improve the health, safety, and/or medical care of rural residents. This fund is administered by the North West REC Board of Directors.

Eligible applicants include organizations involved in community or economic development projects such as: new or expanding private business, local governments and nonprofit community development organizations.
