

# **MANAGER'S REPORT**

### North West REC Lineman Answers Call to Provide Help in Haiti

Our national organization, the National Rural Electric Cooperative Association (NRE-CA), has an international program that has been a global ambassador for the cooperative business model for many years. NRECA International began in 1962 to share lessons learned in the electrification of rural areas of the United States. In the last 50 years, NRECA International has brought electricity to more than 120 million people in 43 developing countries. This program helps to design and implement successful, sustainable, scalable rural electrification programs that improve education, healthcare, safety and economic opportunity.

North West REC has been a longtime supporter of the NRECA International Program by annually contributing \$2,500 to this great program. We were excited that one of our linemen, Gabe Roetman, had the opportunity to get involved by helping in Haiti following the serious destruction that occurred from Hurricane Matthew.



NRECA International sent out a desperate call in October for a mechanic who was needed in Haiti to repair three digger derrick trucks that were broken down. Gabe had enrolled in the Iowa Lakes Community College diesel technology program and worked in that field for four years before changing to the Powerline program, so he had the skills they were looking for. Gabe answered the call and traveled to Haiti on November 17. By the fifth day, he had made the repairs and the trucks were running again. He then worked a couple of days with the line crew in Haiti making line repairs and returned home on November 25, the day after Thanksgiving.

He described the damage to the new cooperative's lines as devastating. The Cooperative Electric (CEAC) was formed in Haiti in 2013 and the first lights were turned on in September, 2015. The CEAC served 1,000 meters prior to the hurricane. Just one year after first turning on the lights, they were faced with rebuilding the system.



We are proud of Gabe's willingness to serve in this way and for his great work on behalf of the International Program and the people of Haiti. "I'm glad I did it," Gabe said. "It was worth it. One thing I learned is that life is very easy here at home."

### Paying for a System that Works Around the Clock

Your electric cooperative has been around for a long time – 78 years to be exact. We've witnessed the many ways electricity has transformed the communities we serve and our rural landscape. Before electricity, today's household tasks were hard work and dangerous. For example, cooking and washing clothes involved a lot of manual labor. Thankfully, practically everything we do - from entertainment to our jobs - is impacted by the ease of electricity.

A lot has changed since electric cooperatives first turned the lights on for rural Iowa. One thing that hasn't changed is our mission to provide electricity to you. Because we've been reliably, efficiently and affordably delivering electricity to homes and businesses for decades, some of our member-owners ask why they still need to pay for a system that should have been paid for by now.

The truth is, most – if not all – of the original system was paid for many years ago. The original infrastructure, such as poles and wires, which was paid for many years ago has likely been replaced. When you have a system that operates 24 hours a day, 365 days a year, equipment needs to be replaced at regular intervals. Imagine if you had a car that was 78 years old and it was driven all day, every day. By now, either the car would not be operating, or every part of the car - from the tires to the engine - would have been replaced many times. The same is true for utility infrastructure. While poles and wires generally have a life span of 30-40 years, some may not last as long due to a variety of conditions. For example, a major ice storm can cause power lines to snap and poles to break regardless of their age.

Paying for an electric cooperative system can be compared to paying for your home. Over many years or decades, the original tract of land and the physical property are paid in full. But infrastructure updates such as a new furnace, air conditioner, windows, and roof are required, not to mention updates to appliances, carpeting, flooring, and paint. Consider how inefficient it would be to heat your home with a 78-yearold furnace. Think of the additional money you'd spend each month due to its inefficiency instead of replacing it with a new model. The same logic applies to your co-op as we need to replace vehicles and equipment over the years to serve you best. Aside from the costs of hard assets at the co-op, there are also the costs of property taxes, insurance, regular maintenance, and staffing that contribute to our overall system costs.

The original co-op infrastructure fulfilled the expectations of that time in terms of reliability and affordability. Over the years, many of those needs have changed. What's in place today is an improved distribution system that allows us to meet increasing demands for kilowatt-hours in an efficient manner. Not only has the need for electricity increased, but our processes now result in reduced outage times. We also work to extend the life of infrastructure through maintenance at regular intervals. Poles are routinely tested for decay, and we trim vegetation throughout our system on cycles to maintain a high level of reliability. To balance reliability with affordability, we upgrade our system when and where it makes sense to do so. We balance financing upgrades and replacements with debt and equity so that we can keep your rates affordable while providing power that you can count on for your home or business.

## Additional Scholarships Awarded

North West REC and Basin Electric Power Cooperative will again be sponsoring four individual \$1,000 scholarships to a dependent of a member of North West REC. There will be one winner from each of the four districts of North West REC.

In addition to that amount, North West REC will also sponsor **four \$750 scholarships and four \$500 scholarships to the runners-up** in each district. We will be able to honor a total of 12 applicants.

North West REC members may qualify if their dependent meets the following criteria:

- Submit the application as provided by North West REC
- Return all completed forms no later than Friday, February 10, 2017

The selection will be based on a combination of SAT/ACT scores and overall grade-point average, work experience, participation in school and community activities, a personal statement of career goals and a written recommendation by a third party.

# NORTH WEST REC OFFERS POWERLINE SCHOLARSHIPS

North West REC is again sponsoring a powerline scholarship. This program is designed to assist persons enrolled in a course of powerline training at Northwest Iowa Community College in Sheldon.

A \$500 scholarship will be awarded to an individual who has met the eligibility requirements. To be considered for the scholarship, applicants must meet the following criteria:

- Reside in the four county area served by North West REC (Ida, Plymouth, O'Brien and Sioux Counties)
- Be a member or the child of a member of North West REC
- Be accepted as a full time student in the powerline program at Northwest Iowa Community College in Sheldon
- File a scholarship application with North West REC by Friday, March 31, 2017

All applicants are required to submit an application form as well as their most recent academic transcript. The criteria for the award will be based upon community and school activities, potential for success and grade point average.

A check will be made out to both the recipient and Northwest Iowa Community College and will be sent to the recipient prior to the beginning of the second semester of course work.
