# Electric co-ops advocate for rural lowa during REC Day on the Hill

Nearly 200 employees and elected directors from Iowa's locally owned rural electric cooperatives (RECs) came to the Iowa State Capitol on March 22 to advocate for important issues during the annual "REC Day on the Hill" event. "Our advocacy day on the hill is an important opportunity to personally touch base

issues that impact rural lowa and rural economic development," remarked Roger Solomonson, board president of IAEC.

Specifically, advocates talked to legislators about a digital sales tax inequity that lowa's electric cooperatives hope to resolve before the 2022 Legislative Session ends. The inequity stems from an unintentional error made in 2018 legislation that requires lowa electric co-ops to pay a new 6% sales and use tax on digital goods and services, even though investor-owned utilities are exempt. Since the law went into effect in 2019, the IAEC estimates that Iowa electric co-ops have collectively paid \$300,000 or more annually in taxes, resulting in roughly \$1 million of unintentional taxes paid by rural lowans through their energy bills.

We thanked House members for supporting legislation to fix this error through HF 2520 and encouraged senators to take up the issue. Following our advocacy event, the Senate passed SF 2372 which is a larger legislative package that addresses various policy issues, including language similar to the House File that would bring an end to this rural energy tax. Iowa's electric co-ops deeply appreciate the work of the House and the Senate on this issue and urge them to come to an agreement about which bill to send to the Governor for her consideration to restore tax equity for co-op member-consumers throughout rural Iowa. Advocates also educated legislators on the benefits of the cooperative business model, including local ownership, cost-based rates and democratic governance. Additionally, several electric cooperatives displayed booths in the rotunda which provided information on topics including economic development, electric vehicles, digital metering advancements, investments in technology, lineman safety innovations and vegetation management work.

## **Pole Maintenance Program**

You probably don't pay much attention to the utility poles found throughout North West REC's service territory, but did you know these tall structures are the backbone of our distribution network?

Strong, sturdy utility poles ensure a reliable electric system, which is why we routinely inspect the thousands of poles found on our lines. Throughout the year, our crews check poles for decay caused by exposure to the elements. They know which poles are oldest and conduct inspections through a rotational process. Typically, a standard wooden distribution pole is expected to last more than 50 years.

Occasionally, poles need to be replaced for other reasons besides decay and old age. Weather disasters, power line relocation, and car crashes are potential causes for immediate replacement. When possible, North West REC communicates when and where pole replacements will take place so that you stay informed of where crews will be working.

One of the key ongoing maintenance programs we do annually, in order to try to improve our service reliability,



is pole testing and treating. Each year we test and treat approximately 3,000 poles.

Poles that are rejected due to excessive rotting conditions are replaced. The other poles are treated with a pole treatment which significantly extends the life of the pole. The very low 2% or lower rejection rate we typically have each year is a strong indication of the strength of the Cooperative's system.


# **Security Light Program to Change**

Security Lights and maintenance are available to our members at the prices below.

#### **Security Light Service Work**

• High Pressure Sodium (HPS) - maintenance......\$50

As of July 1st, or until we run out of parts, we will no longer provide maintenace for the old style HPS security lights, due to the parts no longer being available. Members will have to upgrade to a LED light if they want it fixed.



- Replace a HPS light with an LED light ......\$190

LED lights have a 5-year warranty, but if we find something wrong on the members side causing an issue with the light not to work, we will charge a \$50 service call fee.

#### **Poles**

- Setting a pole for member (Will not set poles for basketball hoops, gateposts, etc)....... \$175

As a member owned electric cooperative, one of the most important events that North West REC holds each year is our Annual Meeting. This provides a great opportunity to report to the members on the past years financial and operating results. It also gives our members the opportunity to participate by voting on director elections and any

other business that needs to be acted on.

The format has changed over the years, and especially the last three years due to COVID, but the importance of the meeting remains the same. This years' meeting was a hybrid format with both an in-person and an on-line option.

Here are a few highlights of the meeting:

- Our four incumbent directors who were on the ballot were re-elected: Jeff Rehder in District 1, Tom Wagner in District 2, Steve Brown in District 3 and Dan Hoffman in District 4.
- Scholarship winners were announced. 75 students throughout our four-county service area will receive \$31,000 in college scholarships for the 2022/23 school year. Congratulations to all the winners!
- During a Q & A panel discussion, Jeff Rehder, NWREC President; Tom Wagner, NIPCO/Basin Director; Lyle Korver, NWREC Manager; and Matt Washburn, NIPCO Executive VP and General Manager, answered some of the most frequently asked questions from our members. We want to thank all the members who sent in their question cards along with their ballot.
- The meeting was recorded, and it has been added to our website for all members to view.
- \$4,000 in door prizes were awarded to members from a random drawing from the on-line and inperson registrations and from the returned ballot envelopes.

# **Board Approves New EV Rebate and Rate**

One of the topics that was the most frequently asked about on the question cards submitted by our members related to electric vehicles (EV). We shared that we support an "all of the above" strategy when it comes to transportation. We are big supporters of ethanol and continue to believe that it has a very important future and role to play. However, as an electric utility, we feel we also have a responsibility to prepare for more EV adoption and to help educate our members on the feasibility and operation requirements of owning an EV.

To help educate ourselves and our members about EV's, we purchased a Chevrolet Bolt three years ago. We have learned a lot about EV charging and how they operate. One of the key things we have learned about



charging is that it will be very important to have our members charge their EV's during "off peak" times. As a result, we will strongly encourage the installation of a load management switch to ensure that charging is kept off peak.

#### • Does NWREC offer a rebate on EV's?

We are offering a **\$1,000 rebate** on a Level 2 charger. If you purchase a new EV, you will want to hook up a 240 volt Level 2 charger in your garage. This will cover most of the cost of purchasing the charger and having it installed. In order to qualify for the rebate, you must agree to have a load management switch installed to ensure that charging doesn't occur during our peak times.

#### • Will the Cooperative have an EV charging rate?

Yes, the Board of Directors recently approved a new EV charging rate of **6.9 cents per kWh**. This rate also includes a \$5 monthly facility charge to cover the extra associated expenses such as metering, transformer upgrade, etc. Just as with the rebate, in order to quality for this rate, a load management switch needs to be installed.

### • What will it cost to charge my EV?

It takes approximately 75 kWh's to fully charge the Chevy Bolt if the battery is completely drained.



You would be able to drive an average of 200 miles on a full charge. Larger vehicles, such as the halfton pickups, will obviously require more kWh's to fully charge the battery. But as you can see, EV's can be quite economical to drive.

We are happy to share what we have learned with any of our members who are considering the purchase of an EV.

We also want to emphasize again that when it comes to biofuels and EV's, we are of the belief that we can and should do both.

## **Prairie Winds Program**

Members of North West REC can support renewable energy through the Prairie Winds program. This program allows individual members to voluntarily contribute to the development of alternate energy production facilities.

Persons who choose to participate in Prairie Winds will pay 20 cents per 100 kilowatt-hour block per month.



Through this program, members will not be directly purchasing alternate energy, but the extra fee does go to support several wind turbines in the Dakotas, which feed wind-generated electricity into the transmission system that powers North West REC.

Switch Makes Cents is a load management program that has been offered to members since 1985. With technology continuing to change and our current equipment becoming obsolete, it is important that we prepare for the next generation load management system Our member service department will be

replacing 7,000 load management switches and nearly 15,000 meters in the next few years. Members will be receiving a call to schedule a time to change out their equipment. We will make every effort to schedule times that are convenient for members when we need to change out equipment that is in the members basement or another area not freely accessible. We appreciate the cooperation we always receive from our members with these projects. Having up-to-date and reliable equipment in place better helps us serve you, our members.

# **Revolving Loan Fund**

North West REC created the Community/Economic Development Revolving Loan Fund (RLF) to improve the quality of life in rural areas by contributing to long term improvement in the local economy.

The RLF is a local funding source with a goal of providing low interest loans to assist local economic and community development projects. Our priorities include job creation and retention, diversification of the local economy, improving the skills of the rural workforce, and upgrading the public infrastructure to improve the health, safety, and/or medical care of rural residents. This fund is administered by the North West REC Board of Directors.

Eligible applicants include organizations involved in community or economic development projects such as: new or expanding private business, local governments, and nonprofit community development organizations.
